- Review the coordination of Audit efforts to ensure completeness of the coverage and promote the effective use of the audit resources. Review adequacy and effectiveness of the organizations' internal audit, governance processes, risk management and internal controls, including information system, programme management and security controls, the quality of the financial and other management information produced to ensure integrity and reliability, any related significant findings and recommendation of the internal and external auditors together with management's responses thereto.
- Examine and review the annual financial statements before final approval thereof. Review compliance with all regulatory and other related requirements. Review any significant incidents of a criminal or irregular nature.

Requirements:

- Experience in any of the following fields: Internal Audit / Risk Management.
- Applicants should be in a possession of a Post Graduate degree in Internal Auditing/Risk Management/other relevant qualifications together with CIA/CA(SA) certification.
- Minimum ten (10) years proven Internal Audit/Risk Management at senior management level.
- Minimum six (06) years serving as an Audit Committee member
